#5. EXECUTIVE REPORTS – 10 min

MOTION Moved: N. Alideeb Seconded: A. Taha

- N. Alideeb discussed that the UTMSU presented a list of student priorities, ranging from grade forgiveness, student center expansion, divestment from fossil fuel and more, to campus council. Overall, it was well received. QSS meetings also started once again and discussions regarding improving the Shuttle Bus service have been held. Next year, there will hopefully be 4 new shuttle busses with improved shock systems and better heating/air conditioning. The will also be meetings with UTMAGS to discuss the concerns regarding where the funds for the Student Life Initiative are going towards.
- P. Zhao has been working on the GTA-Wide U-PASS campaign. He explained that the work task force will be meeting tomorrow to collect student data and surveys to be used to lobby members of Metrolinks and other municipalities concerning transit. Mr. Zhao also discussed the first ever event to be dedicated to celebrating Chinese New Year. The event consisted of people coming together to enjoy hotpot, performances and games. As the event was very successful, he hopes that this event will continue to occur in the future years.
- V. Demello debriefed the December Exam De-Stressors. She discussed how pamphlets were made and put into the De-Stressor bags, which outlined all the resources that students have access to. V. Demello also discussed the recent victory achieved where the \$35 fee for getting your exam re-marked has been waived for students. She is also working on getting rid of the \$15 fee if students want to view their exams as well as increasing the deadline date for the Credit/No Credit option. There is also discussion about proposing an equity breadth requirement.
- M. Hopkins has been working on Black History Month events alongside Mr. Subban. The month will be dedicated to raising awareness and teaching students the importance and significance behind Black History Month. Ms. Hopkins also discussed Multicultural Week that occurred the third week of January. The week's festivities included a cultural food day, a cultural clubs day and a concert. The turnout for the festivities was very successful. An Ontario General Meeting was attended with CFS where attacking Islamophobia was discussed and its actions have been revamped.
- M. Baig discussed the Intersectionality event and how racialized people are not represented in Mental Health campaigns. She also discussed the Good Food Box and how there have already been about 15 orders placed. She hopes this initiative will continue for many years to come.
- V. Demello discussed on behalf of Mr. Subban about the Rated-R Zero Pub. She explained that the event was in collaboration with the ICCIT Council and the Rhythm Dance Club. The event successful.

Be it further resolved that the UTMSU Board of Directors approve a cost of living increase to the UTMSU Society be from \$1.06 per session, per part-time student, a member, to the newly adjusted rate, with a CPI increase based on the Ontario December 2015 to December 2016 consumer price index determined by Statistics Canada.

M. Sajjad explained that the fee, if approved at Governance Council, will increase 2%, from \$14.35 to \$14.64.

M. Sajjad explained that thanks to the work of the executives, they were able to negotiate with MiWay, a lower increase fee and a new contract for the next 3 years. The increase was decreased from 9% to 7%.

Mr. Zhao explained that Standing Rock is an indigenous reserve through which a pipeline is in the process of being built. This construction is an environmental hazard to the indigenous people as it causes them to have no access to clean water. The indigenous people refuse to move as it is their land, and thus, as a result, the government have released tear gas attacks. Due to the attacks, the indigenous people require support in medical aid and other living supplies, which this \$1000 will go towards helping.

Preamble

Orientation is the first opportunity that our Students' Union has to make an impression on incoming and returning students. It marks the beginning of a new academic year and offers the ability to welcome members back to the university by offering them a showcase of campus life and increasing student spirit. The Orientation Coordinators of the Union have the responsibility of planning and hosting the Union's annual Orientation Day as well as carrying out the responsibilities stated in this policy.

The Union shall hire Orientation Coordinators to carry out Orientation as well as other delegated duties.

Orientation Coordinators work under the supervision of the Vice-President Campus Life, President and Vice-President Internal and Services, respectively.

Hiring Timeframe

The hiring of the Orientation Coordinators process commences at the beginning of the winter session. The following is a timeframe, on a month basis, that must be followed as part of the process:

- January: Job posting circulated (no less than 20 days) December: Job posting circulated (no less than 14 days)
- February: Hiring Committee Struck January: Hiring Committee Struck
- April: Interview Process and ratification of coordinators February: Process and ratification of coordinator(s)

Hiring Committee

The Hiring Committee for the Orientation Coordinators must consist of outgoing and incoming executives. The Hiring Committee begins the selection of candidates and interview process only with the incoming executives elected.

The hiring committee composition is as follows:

- Outgoing and Incoming President, outgoing Vice-President Campus Life, outgoing and incoming Vice-President Internal and Services.
- The outgoing orientation coordinators shall be part of the process, at the discretion of the Hiring Committee, with no voting privileges
- The Executive Director (non-voting)

The Hiring Committee makes the final decision in the selection of the Orientation Coordinators.

The Union's Orientation Coordinators shall take office at the earliest date possible.

Orientation Coordinators Responsibilities

Union Orientation planners should formulate a set of base principles and goals based on the previous year's experience and on their own concerns, which are consistent with tenets of the University of Toronto's core policies relating to equity, accessibility and diversity, and include a commitment to fiscal responsibility. The Union should position itself as an effective and independent student partner in Orientation activities as suggested in the *Stepping UP Academic Planning Framework*, and should work constructively with other University partners to ensure Orientation programming is being planned in the best interests of Union's constituents. The Union should work to ensure that the University of Toronto central administration play a major role as an equal partner in providing campus-wide Orientation programming, as outlined in the Student Affairs *Report of the Task Force on Orientation and Transition, Final Report (2003)*. The Union should follow the basic tenets of the *Stepping UP Academic Planning Framework* pertaining to Orientation planning, cognizant that these principles are useful as a foundation for cooperative interactions between Union and the University of Toronto administration.

Responsibilities include:

- Organizing and planning Orientation Week
- Coordinating the UTM Carnival
- Overseeing the financial aspects of orientation, including fundraising
- Filing bi-weekly reports to the Executive Committee and present motions for approval
- Filing a final report to the Board of Directors (use 2005-06 Orientation report as an example)

Orientation coordinators must set up a timeline and project management to help implement the planning of Orientation.

Orientation Coordinators must report to the President and Vice-President Campus Life on a daily basis. They must also work with the Vice-President Internal and Services in regards to the finances of Orientation.

Be it resolved that the following Issues Policy – First Nations, Metis, and Inuit Education be approved as presented:

First Nations, Metis and Inuit Education

Preamble

The University of Toronto Mississauga Students Union recognizes that First Nations, Unit and Metis people are indigenous to the land that is currently occupied by Canada ad have inherent rights and titles, and that students should have the right to self-identity their first Nations, Inuit and Metis ancestry, regardless of labels used by the federal government's Department of Indigenous and Northern Affairs. The University of Toronto Mississauga Students Union recognizes First Nations, Inuit and Metis people's inherent right to unlimited access to traditional and non-traditional education. Education at all levels is a First Nations, Inuit and Metis and Treaty right recognized in the Canadian Constitution Act of 1982.

The effects of the legacy of colonial oppression of First Nations, Inuit and Metis people and the subsequent access available to post secondary education are exacerbated by regressive government policy, which has perverted the Treaty right to education to exclude post-secondary

education and denied access to thousands of First nations, Inuit and Metis students. Although education is a provincial jurisdiction defined by the Indian Act, regardless of whether schooling is pursued on or off reserve. At present, non-Status First Nations, Inuit and Metis students are not covered to them through the Department of Indigenous and Northern Affairs Post-Secondary Student Support Program (PSSSP) is not available.

In addition, the funding provided by the federal government for Status First Nations through the PSSSP is inadequate to ensure access. Funding for the PSSSP is distributed by band councils under their own eligibility criteria. Finding for Indian and Northern Affairs' Post-Secondary Education Program, which includes the PSSSP, has been capped since 1996 and has failed to account for inflation and population growth. This funding shortfall, couples with the increased demand for a post-secondary education and dramatic provincial tuition fee increases in Ontario, has progressively undermined the value of the federal government's contribution to the PSSSP and other support programs since the mid-1990's.

These factors create substantial barriers to post-secondary education for Aboriginal learners and Canada continues to exist on occupied land. Therefore, it is important that all students gain a better understanding of the historical and contemporary issues that First Nations, Inuit and Metis people face on their land. As it stands, students are not required to complete a course on First Nations, Inuit and Metis studies, and most programs do not offer such courses. Policy

The University of Toronto Mississauga Students' Union supports:

- access to funding for First Nations, Inuit and Metis people that ensures the opportunity to participate in, and complete, a quality post-secondary education; and
- educational opportunities that reflect the lifestyle and needs of First Nations, Inuit and Metis communities: and
- full and fair funding for First Nations, Inuit and Metis access to post-secondary education and other support programs that increase annually to account for inflation and population growth; and
- recognition of First Nations, Inuit and Metis languages for post-secondary entrance requirements into relevant programs; and
- recognition of First Nations, Inuit and Metis languages as an option for post-secondary institution language course requirements; and
- promotion of understanding and respect for First Nations, Inuit and Metis cultures, knowledge, languages, spirituality, history, and technology in the Canadian post-secondary education system; and
- the inclusion of indigenous spiritualties in religious observance policies at post-secondary institutions: and
- the authority of local Band councils to administer federal funding for First Nations, Inuit and Metis post-secondary education and other student support programs; and
- campaigns initiated or supported by the National Aboriginal Caucus; and
- the introduction of Indigenous Course Requirements for all students in all programs in all Ontario post-secondary education institutions; and
- the inclusion of First Nations, Inuit and Metis students, Faculty and staff in the reaction, development and any revision of Indigenous Course Requirements and indigenous content in curricula.

The University of Toronto Mississauga Students Union opposes:

 Any cap on government funding for First Nations, Inuit and Metis access to post-secondary education and other support programs;

- Government systems which grant access to post-secondary education for First Nations, Inuit and Metis students through loan-based mechanisms;
- Curricula that ignores the contribution made by Indigenous cultures to the history of the formation
 of North America or the ongoing contributions made by such cultures to the social fabric of modern
 North American societies; and
- Any change in municipal, provincial or federal policy that does not uphold the right of First Nations,
 Inuit and Metis people to self-governance and official recognition.

Preamble

Colleges and universities have a collective power often referred to as shareholder activism, wherein they can set social trends within corporations based on who they chose to invest or not invest in. this can be a powerful agent for change, and has the ability to shape the provincial and national agenda. This collective power is similar to the way in which students use their collective purchasing power through the Ethical Bulk Purchasing Network to set ethical and sustainable trends in production markets. In the past, divestment strategies have brought major victories. One example is when students successfully pressured their institutions to divest from South African Apartheid, which contributed to the fall of Apartheid in South Africa.

More recently, students' unions have been lobbying administration to divest from a number of unethical or morally ambiguous investments, including but not limited to, fossil fuels, companies supporting the illegal occupation of Palestine and companies that benefit from the American forprofit prison industry. The University of Toronto Mississauga Students Union is in solidarity with all oppressed people, and opposes all forms of apartheid. Divestment campaigns push Ontario colleges and universities to be mindful of what companies they put student's tuition fees towards. In funding corporations, colleges and universities are complicit in stealing and destroying indigenous land and communities, committing human rights violations and supporting exploitative labour practices.

Calls for divestment are often accompanied with a call for the creation of Ethical Investment Policies for the college or university in question. These policies can institutionalize the political values of a college or university. This dual approach – divestment and ethical investment – brings together multiple student groups and campaigns to create long-term change in regards to future investments by colleges and universities.

Policy

The University of Toronto Mississauga Students Union supports:

- Creation of Ethical Investment Policies on all college and university campuses in Ontario and across the country, and;
- Divestment from unethical and/or morally ambiguous companies, organizations and corporations.

The University of Toronto Mississauga Students Union opposes:

- investments in companies that contribute to climate change, human rights abuses and violations, the prison industry, imperialist efforts around the world and any other unethical or morally ambiguous investments.

Be it resolved that the following Issues Policy – Affordable Housing be approved as presented:

Preamble

While the cost of college and university serves as the most significant barrier to accessing higher education, there are a myriad of economic barriers that shut out many communities from our institutions. Across the province, students have reported finding it nearly impossible to access safe, affordable and accessible housing, while the waiting list for affordable housing has reached record highs. This issue is made worse by the difficulty in finding affordable transit options and accessible quality food services.

The inability to access safe, affordable and accessible housing is an issue that disproportionately impacts marginalized communities, more specifically people living with disabilities, Inuit, First Nations, and Metis people, Racialized people, and queer and trans individuals, particularly youth; all of which are more likely to live below the poverty line.

Recognizing that housing is a fundamental right and a social determinant of health, students have long called for the government to invest in affordable housing, citing it's economic and social benefits to our communities.

Policy

The University of Toronto Mississauga Students Union supports:

- The elimination of homelessness through increased public investment in affordable housing;
- Increased public investment in co-operative housing;
- Increased investment in affordable and co-operative housing made accessible to people living with disabilities;
- The use of inclusionary zoning policies, where it does not contribute to gentrification, to ensure affordable housing is built into new developments; and
- A landlord licensing structure that requires private landlords to maintain states of good repair and respect tenants' rights;
- Increased support for, and promotion of, programs that assist people to locate affordable housing opportunities, particularly programs that are by and for marginalized communities

The University of Toronto Mississauga Students Union Opposes:

- Creating affordable housing units in areas where there is not access to quality public transit, services and shopping areas; and
- The privatization of public affordable housing units; and
 - The continuation of oppressive processes and systems that allow for the continued disproportionate homelessness of marginalized communities.

1. Anti-Blackness

The organization surrounding the anti-blackness town hall meeting could be improved. There was an issue with one of the key note speakers withdrawing the day of the promotions. A solution to resolve this issue was reaching out to black student organizations on campus (such as ASA, BSA, NSA, and the Somali Student Association) for a possible collaboration on the town hall meeting. The anti-black town hall meeting serves as a space where students can attend and voice their concerns.

The point that UTSU stopped reaching out and including the student organization BLC in efforts to fight against the issue of anti-blackness was brought up by the UTSU. There was a previous attempt for a collaboration by the UTSU with BLC, however, BLC refused to work with the UTSU due to conflict of interest concerning an outstanding lawsuit.

There was concerns as to why Information regarding the lawsuit is not spread to the public as students should be aware of the matter. Those students who are actively trying to obtain information deserve answers as well.

UTSU acknowledges that their position on anti-blackness and their actions to advocate for the students who are marginalized could be greatly improved. They plan to release any information about the lawsuit that can be released shortly. The UTSU will also try to mend its relation with BLC and figure out ways fix their anti-blackness label.

2. 2017 Spring Elections

An Emergency Board Meeting will likely ensue shortly, concerning the topic of elections as dates have not been confirmed as of yet.

3. Orientation Debrief

The UTSU are working towards implementing a Fall Reading Week. This would allow Orientation Week to occur during the same week across all three University of Toronto campuses.

The UTM orientation week went fairly well as there were many different events and the feedback from students was positive. Some concerns include: better communication with volunteers regarding where to direct students, bussing company payment. Suggestions to improve next year's Orientation Week include: more water and ice creams stations so that more students have opportunities to cool off, shortening the time between the carnival and the evening club event (as this allowed students to pre-drink in between), better club event security.

To minimize the confusion with bussing after the evening club event and to reduce the number of students heading off to pre-drink, there was a proposal to hold an after party on campus as it would be safer. The only complication would be planning in accordance with the University

The UTMSU are looking to amend the policy such that the hiring of OC's can be done earlier in the year.

4. Sexual Violence Policy

The sexual violence policy was updated, however, the new sexual violence policy reflects little substantial changes (mainly clarified language and highlighted definitions).

Both the UTSU and the UTMSU want to focus on pushing for an end-of-the-semester review of the new sexual violence policy.

The UTSU has been working on two initiatives. The first initiative being a website that would include links to all the resources offered by the university (academic-related, community-related, support-related...etc.) The second initiative being an online database where victims can anonymously log the abuse of the perpetrators such that others can be aware and cautious. This serves to especially help those who are uncomfortable approaching administration about this sensitive issue.

The UTMSU is working to further include the Peel Region Police in the sexual violence policy, as they are the ones who are called to deal with these cases.

5. Next Meeting

The next UTSU-UTMSU Executive Meeting will most likely take place next semester. The date will be confirmed once schedules are figured out.

Anick suggested to do more promotions and advertising before Academic Advocacy Week. It was noted that the time for transition between Cubs Week and Academic Advocacy Week was quite rushed, and thus could have contributed to students not knowing about Academic Advocacy Week.

It was also suggested to increase the incentive (food) and increase the advertising of the incentive for attending workshops.

#7. DISCUSSION ITEM: Governance Awareness

Ms. Demello discussed briefly what Governing Council is and how they are who make decisions at UTM (such as the million dollar rock purchase). It was stressed how there is little student representation on the council which is problematic. More outreach needs to be done in order to get students to actually attend meetings.

There was a suggestion to do class talks to raise awareness among the students, however unfortunately, UTMSU does not have the number capacity to create sufficient change or to show Governing Council that students are in fact aware in order to make change.

Sahar suggested making a short video, more focused on the visuals to be able to post on social media. The goal of the video would be to first educate the students about Governing Council and how decisions at UTM are made, and then to outreach so that students come and attend the national day of action on November 2nd.

Ms. Demello wants to push for the option of allowing students to be able to revoke a previously used CR/NCR option after a subject post change is made. This is for the case where the course that was previously CR/NCR is now required for the newly switched subject post.

There is discussion concerning the unawareness of students about petitions and important deadline dates if interested in withdrawing, CR/NCR, and/or dropping courses, especially among first year students. It was suggested that an informational booklet be made for first year students to be distributed during Orientation.

To improve the communication and advertisement towards students about academic policies, procedures, and deadlines, it was suggested to post more frequently on social media, and to create a link on the UTMSU website specifically dedicated to it. Another suggestion was to speak about it in the monthly vlogs and to create infographics.

It will include the noise level at each location, food options in the area, bus routes, if necessary, to reach the location, and the hours of operation. The first series is expected to release at the end of November. The second series will feature dentists, therapists, doctors...etc. in the area, along with the map of directions to arrive at the destination. The third series will feature a 'self-care' guide, including ways to cope when feeling overwhelmed, sad, or anxious. The fourth series will feature information on how to be more eco-friendly and sustainable.

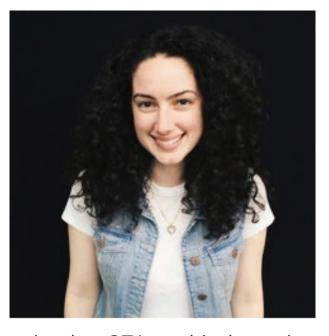

UTM CAMPUS COUNCILS

Over the past few months the UTMSU has been presenting to the 3 UTM Campus Councils - Campus Affairs, Academic Affairs and Campus Councils. Our presentations have included an overview of the UTMSU because often times members of these committees do not know exactly what the UTMSU provides for its members. The last portion of each presentation had a section about student priorities that coincide with the mandate of each council. For example, during the Academic Affairs committee we talked about the importance of changing our academic policies to make them more accessible, eliminating unnecessary Registrar fees, summer school course expansion, an equity breadth requirement, divestment from fossil fuels, and the Grade Forgiveness policy. At Campus Affairs and Campus Council, we discussed co-op, student center expansion, reducing, and eliminating tuition fees. We received generally positive feedback regarding all of our student recommendations, but we're looking forward to following up with different individuals to ensure that these priorities are met.

UTEAU MEETINGS

The UTMSU attended a meeting with the University of Toronto's Employees Associations and Unions where we discussed a number of ways to better serve our collective members (e.g. TAs in CUPE3902). We also discussed an open letter condemning President Gertler's decision to reject the call to divest from fossil fuels. This was my first UTEAU meeting but I think there are many opportunities for our unions to work together to better serve our student works and works at the university who do so much to support our students. I will be speaking to an individual later in the week to plan an event to bring our members at UTM together for a mixer! Stay tuned for more!

QSS

The Quality Services to Students committee has resumed meetings since the beginning of the year. I would like to thank the many individuals who have attended, taken notes, and made recommendations on the quality of different services ranging from the Shuttle Bus and International Education Centre, to the Career Centre and the Health & Counseling Centre. Representatives from the UTMSU, UTMAC, UTMAGS, and Residence Council are meeting with the Dean of Student Affairs to renegotiate the QSS terms of reference to account for the concerns that have been brought up in recent years. I will give an update after our next meeting!

CFS ONTARIO GENERAL MEETING

The CFS Ontario General Meeting took place between January 19th and January 22nd. The UTMSU submitted 4 motions for this meeting with topics ranging from improving the Ethical Purchasing Network, Boycott Divest & Sanction the Israeli Apartheid, creating CFS-Ontario commissions on each member local campus, registrar fees and supporting Bill 26 which calls for greater support for those who have experienced sexual violence. All of our motions passed, so if you want more information please do not hesitate to ask. I am also very happy to announce that I have been elected as the new Chairperson for the CFS-Ontario; I will assume office in June 2017. I look forward to continuing the work of our students' union and many other member locals on a provincial level!

Things kind of slowed down in the office during December due to exams and the winter holidays but it's now mid January and we are moving at a quick pace to achieve all the goals we had set out for ourselves. I can't believe there are only 4 months left of this amazing experience, and now that the UA team



has all positions filled, we are able to work efficiently and effectively in the best interest of students.

DATES AND DEADLINES

During the months of December and January, I created two vlogs that discussed the important dates and deadlines for the relevant months. They included a lot of informative dates and I also shared the link to the latest Squad TV episode so students can stay informed with what's happening at UTM. I have also started to post some important dates on the UTMSU Facebook page, for example, reminding students who are graduating to declare graduation or students to select the credit no credit option on time.

EXAM DESTRESSORS

As exam time was approaching in December, the UA portfolio in collaboration with the Equity and Campus Life portfolio, worked to create some exam destressors for students. We reiterated the fact that it's important for students to take the time out of their busy studying schedules and to just relax and take care of her mental well being. We had destressors during the exam week that included planting, arts and crafts, and drinking warm beverages. We had also hosted an event called UTeaM: Mental Health and the Pressures of Getting a 4.0. At this event we discussed mental health and the importance of it, not only during exam season but throughout the year. The Canadian Federation of Students provided us with amazing pamphlets with information regarding mental health, some services, and also a turtle that they can color. The exam destressors were very relaxing for students and we also had some prizes and giveaways as incentive for folks to attend. We hoped to create a variety of destressors this year, and we definitely did do that!



ONLINE INITIATIVES

We have worked very hard to create different accessible platforms online, and different graphics so that students have a way of going through their undergraduate experience at UTM efficiently and effectively. One of the things we are super proud of bringing back, is the Anti Calendar. After 16 years we have finally brought it back, and it will help students when they are doing course selection, and will also encourage them to fill out their course evaluations. Other graphics we have created includes a graphic about self care, information about the health and dental plan, and a tri campus policy and appeals guide! All these graphics are on the UTMSU website.

ACCESSIBLE EDUCATION AND ACCOMMODATION PROCESSES

We have had a major victory in the month of January! Through discussions with the Office of the Registrar, the UTMSU has lobbied to eliminate the 35\$ exam re-mark fee. This fee was a major burden to students who deserve the right to get a re-grade without having this 35\$ penalty. We are now working to lobby administration, and working towards the elimination of the 15\$ exam viewing fee. Through discussion with the Dean of Academics, as well as the Office of the Registrar, we are looking to extend the deadline for selecting the credit no credit option. I know this is something that students would be interested in as they have brought the concern to me and other folks that work within the union, on multiple occasions. We hope to gain this victory, to ensure that students are getting the best out of their education and also to ensure students are able to take courses they are interested in without complete penalization and without the stress of constantly worrying about their GPA. The accessibility coordinator, Karina, is working to create accessible education videos to inform students about services that are provided to them, and using language to destigmatize the ideas surrounding accessibility, disabilities, and mental health. We have done a call out to students who identify with having a disability and are creating the script so we can film! We hope to educate and inform students on things they may not have known before, as UofT can be known for its lack of accommodations and lack of care for mental health. Another thing the entire University Affairs portfolio is working on is a UTMSU syllabus. This would be a platform on the UTMSU website and hopefully on portal as a link, attached to every students syllabus. There are a lot of student rights that are missing from the general syllabi, as professors have a choice as to whether they want to include things like students rights, and the equity statement, so with this UTMSU syllabus, students will have access to all the information they need in order to pass their classes successfully and ensure there is equity as well.



GREEN INITIATIVES

Over the past few months, we have been trying to engage our clubs and societies to utilize the green products that we have. We have created a new poster to inform students about the products that we offer, in hopes of more requests. The sustainability coordinator alongside the UA associates and myself are working towards creating a guide to being eco-friendly, to ensure that students are living a sustainable lifestyle! We are also working to create a recyclable action figure with interest from clubs and societies to create awareness about garbage disposal and proper disposal of recycling items. This is an upcoming project and we are collecting plastic water bottles and other items. This will help answer any questions students have regarding the bursary process or how to submit the best applications.

GOOD FOOD BOX

We recently started the Good Food Box this semester and completed our first order. I'm still working out a few kinks with the system, previously I was not told that we needed to place in the order for the boxes 7 days in advance and I put it in 4 days in advance and now we have to wait till the following cycle. Our first delivery is going to be Thursday, January 26th at 12pm. I'm extremely excited about this, we're going to bring locally grown and organic fruits and vegetables for students. This semester I'm going to try and further advertise it to get as many students onboard with this new initiative.

MANDATORY EQUITY BREADTH REQUIREMENT

One of our platform points had to do with pushing for a mandatory equity breadth requirement at UTM. An important quality many employers are looking for is knowledge regarding equity and diversity. This way employers won't have to do HR trainings or equity trainings, which minimizes costs. We believe it is important for students to be trained in all aspects of equity and diversity, along with humanities and science breadth requirements. Vanessa and I are working on putting this together and doing research to submit to the university.
