Executive Report #3 – June 23rd – July 15th, 2015

Executive Summary

The past month has been a hectic month with meetings, outreach and planning. 1. Pride Picnic

On June 23rd I and couple of other UTMSU representatives attended the pride picnic that took place at the UC Quad downtown. This picnic was a collaboration with various student unions within UofT including UTSU, APUS and SCSU. UTMSU helped with promotion of the event as well as participating in the event. There was a good turnout to the event which was a way of showing pride within the University of Toronto community.



2. Racialized Students Coalition

The aim of The Racialized Students Coalition is to make available to UTM students such a space where we can finally speak openly about the issues concerning race that have so often been dismissed. This space will allow students of colour to collectively heal, empower and mobilize one another, while also discussing ways in which we can resist and challenge issues of race and privilege.

The RSC will hold weekly meetings as well as monthly reflection events in which we will aim to finally give racialized students the opportunity to lay bare their own narratives in their as well as listen and learn from different key speakers who will come and talk to us. Together we aim to foster an educated and anti-racist and environment within our campus.

Members of the board including myself asked for movement on the part of the coalition to start happening. The Anti-Racism coordinator, The VP Equity and I have been working to ensure the meetings happen and we will be working to make sure it continues to happen. We have successfully held 2 meetings of the coalition and the hope is to run educational campaigns in the coming weeks to help students understand certain key topics terms used within the student union spaces. We have also discussed events that will be happening for the rest of the year that include particular topics. For more information about the coalition please feel free to ask me, vpequity or the anti-racism coordinator Sherry Ghaly.





3. Associate Training

Also on June 23rd we had a training session organized for our 14 associates. We wanted our associates to get a basic understanding of the operations of the union as well as meet all the executives and fellow associates. The training spanned 2 hours and we were able to go over the constitution and bylaws, internal operations, campaigns and outreach work amongst other topics. We were able to provide this information to our associates and we have been following up with our associates to ensure that they get work done and we are on top of our things.

4. Meet and Eat Exam Destressor

The meet and eat exam destressor was part of our on-going exam destressor series geared towards providing students with a release during exam time. Every year during exams we provide students with food to help with these destressor and this year was no different We provided students with burgers, hot dogs and corn. We also had music playing in the background and sports games including soccer and football. It was a successful event we handed out over 200 burgers 100 hot dogs and 100 corn cobs within an hour.





5. UTMSU collaborations with External Partners

This year one of our main goals is not just to connect with the community here on our campus but also the broader community in general. So far we have collaborations set up with the New comer Centre of peel as well as United Way of Peel. Both these organizations reached out to us for long term collaborations geared towards bettering the student experience on campus. The newcomer Centre hopes to work to better transition new students in Canada including but not limited to International students. United Way's mandate is to alleviate poverty within the Mississauga community and raise funds to help with their operations throughout the year. The hope is to collaborate with United Way throughout the year with charity events to raise funds to help the city of Mississauga.





6. UTSU

As the UTSU designate I will be working to make sure I provide feedback in my reports about the ongoings of the UTSU. Right now they are currently in the process of hiring an executive director. They are currently in the final stages of the interview process and an ED should be hired by the end of the week. We have yet to completely finish a board meeting. At the last board meeting we were in the process of discussing a motion pertaining to a BDS committee but that motion was moved to the next meeting, which will most likely be an emergency board meeting. We have about 15 commissioners of the union now. It is important to constantly engage commissioners to keep them updated on the work of the union so they can carry on this work to the broader membership. We had a lot of important discussion pertaining to mental health facilities on campus and how these services could be much more accessible as well as our campaign on consent culture. This discussion had us talking about how we can better our services as well as the Universities sexual assault policy. We also had discussion about an equity course on campus and a number of students expressed interest in starting a working group to do research on this topic. The hope is to continue the work of the commission and take it down to the ministry level. At the ministry level we will continue these discussions in depth and bring it back to the commissions level at the next commissions meeting in August.

1) Academic Societies Training/ Handbook Update

We finally had our Academic Societies Training this past month on July 13th. I'm so happy with the turnout and the content of this training. We had just over 50 Academic Society Execs, and guest speakers like the Academic Dean, Amy Mullin and folks from the Health and Counseling Centre, the Robert Gillespie Academic Skills Centre, CFS, and the UTM Equity Officer. Students were given a UTMSU101, Societies 101, a talk about well-being, equity sensitivity, social media, and time and stress management. We also told societies how we want them involved in the UTMSU Orientation 2015. All the students and guest speakers were very happy about how this training played out. I'm very grateful for the entire UA team that helped put this together and the execs for doing their part in this training.

2) March for Jobs, Justice and Climate Change

On July 5th Ebi, Hashim, Genevieve and I went to the March for Jobs, Justice and Climate Change along with some of our friends from other unions. There were over 10,000 people present at the March that went down University Avenue to Allan Gardens. It was amazing to see so many diverse people; it just goes to show that these issues affecting our society right now, affect every single person and if we don't do something about it then there will be serious ramifications for generations to come. We can make a change starting with the upcoming election.

3) One-on-One Meetings with Incoming First Year Students

I, along with Hashim and Salma, have been meeting one-on-one with incoming first year students to teach them how to use ACORN (the new software for enrolling in courses), paying their tuition online, where to view their course requirements and how to create mock timetables. We have also been giving them tips and tricks on how to be successful in First year, as well as advertising the UTMSU Orientation. I really like this one-on-one time because you get to know the student on a more personal level and they feel like they can come to you for anything throughout the year. Students find it less intimidating than going and seeing an academic advisor (and the wait times are shorter) because it's a student-to-student type of conversation.

4) Ramadan Iftar Dinners

The month of Ramadan has passed too fast, yet not fast enough. Our potlucks, BBQ and the final, annual Iftar (on July 14th, in the Blind Duck and the Presentation Room) were huge successes. The food for the potlucks were brought in by members while the final event had food ordered from Sliver Spoon just like last year. The dinners leading up to the final iftar had around 50-75 people in attendance while the final iftar had around 200 people. These were hosted in collaboration with UTMSU's Muslim Student Association.

5) Student Recognition Award Deliberation

I struck a committee with UTMSU representatives and the Financial Advisor from the Office of the Registrar to deliberate 22 applications for the UTMSU Student Recognition Award of Achievement Scholarship. This committee awards students monetary awards based on their academic standing (3.0 or above) and their extracurricular activities on campus. The award winners will be announced in August when their CGPA is confirmed and funds are released. Another meeting is scheduled next month to finalize the recipients.

F. Otello-DeLuca - So this is a budget that I had come up with. We are looking at a total surplus of around \$1,200. Which gives us a little bit of wiggle room, but that is to be determined. We are selling around 100 early bird tickets at \$105, and normal priced tickets at \$125. Last year we sold around 618 tickets, and we are selling late at \$140. Same day price will be \$150. We have a \$10 buy in for the boat cruise party, and around 950 froshies can attend due to amount of leaders as well. Around 1200 people attended last year. \$181,000 ticket sales alone. We have bandanas, etc. We got 3 different quote from 3 different people, and whether the materials were ethically made. In total, for promotional costs, is going to be over \$33,000. We ended up saving money on this. Leader training costs - the first training and last are sponsored for food. The one in the middle will be a small cost. Subway and Boston Pizza are the sponsors. We split the costs with Scarborough for the joint training. Roughly around \$4000 for the first day. There will be a pep rally afterwards. Day two - around \$30,000. If we don't get an artist, we'll just put the extra money towards food. The paint party is \$2000. Photo booth, hypnotists, and the dinner might come in a little bit before this. Day 3 - the Photo Booth, UTMAC day, and pub night. Breakfast in the morning, roughly around \$5000 on that, and same with lunch. This covers security costs, etc. Decor for the pub night, covers the cost for the DJ, and photo booth. If anything, the entire cost for this day will go down. Day 4 - downtown. And the boat cruise saved us \$10,000. Lunch - day we have shawarma. We pay for the bus and the boat cruise. \$45,000 day. Last day - Beach party and a Blue Jays game. The beach party should be around \$2,000, then roughly around \$1500, then food would be continuously through the beach party. We're getting 1000 tickets for the Jays Game, and if we have more then they will hold 200 tickets for us. And there is bussing for that day. Day 6 - carnival day downtown, pizza, and truck

with speakers and bussing. 29 Busses per day (most likely). Pre-orientation expenses (salaries for OCs and Sponsorship), and un-expected costs. Vehicle costs, kits, flag materials, etc. Projecting sponsorship of \$45,000. We unofficially have \$33,000, and so we are projecting we can get another \$7500. We are introducing a mature student orientation, which will cost \$2000, and around 50 mature students coming to the Jays Game.

Orientation Formal: price of \$33 per head, and project the same price. Those are our total expenses, and it might change because of this cost. We don't have a venue as of yet. Depending on the cost per head, prices may change. Not all leaders come to the formal. This is not the final budget.

Activities were from the previous calendar. All of these students are second year or upper year. On-campus activities are regarded higher than off campus. This is for students with financial need. I want to have a good idea with these applicants, so we're all on the same page. I want to have someone who is well rounded, not only good in academics, or extracurriculars, and diverse extracurriculars.

W. Khogali - Extra curricular activities are a good indicator, and they may have been already been praised in other groups. As well, involvement in our student societies and groups. Thats where most of the involvement happens. And their personal statements in regards to personal growth and learning outside of the classroom. This is another factor to consider.

F. Yun. - Depth of involvement, and participation. There is a difference between handing out flyers and starting a club. Organizational skills and the depth. If there are candidates that are very close, academic standings should be the deciding factor with this.

W. Khogali - There is not a specific quota of awards to give out. It all depends on the committee and the applications.

N. Alideeb - \$12,435 for awards. Applicants can get from \$1000 to \$3000. 22 applicants.

Eric - I am the Food Centre Co-Ordinator at UTM. I'm here to talk to everyone and to let you know what happened last year. Throughout the year there were issues about how the food centre should be run, and how it reflects the members. At the time I was a member of the food centre. There has been an issue with the language, and the constitution drafted was a recourse. The coordinator at the time didn't know what the budget was, and seemed to have a difficult time finding out what it was, and the budget didn't carry over. This has to do with equity and equality, within the food centre. This wasn't very clear, and it does get very different with volunteers and coordinators. Knowing people inside and outside of the food centre is very different, and allergies. How to run the food centre basically. It has been difficult to get Food Justice started, but its happening. This would be a type of coalition, and the members of the food centre would not be able to vote, just the members of the coalition. We're going to be working on drafting the language and making sure everything is air tight. We will also work on the budget, and hopefully done by the end of summer or sooner.

U. Agebeyegbe - Parts of this do not need to be added within the policy. Many things are common knowledge. The Food Justice committee should be open to everyone. The people who have been running the food centre know what they're doing and we've kind of been hands off on it. In the last year we found out that they had been lied to about the budget. So last year they had it in their mind that we were going to do the same thing to them. The food centre is a levy by UTMSU. In some form we need to show that this is a UTMSU service for the students. This has been an equity issue. Its a human rights issue. Operational standards, it is a service, but it is an equity issue. We should have a lot more say in how it is run.

F.Otello-DeLuca - There is a stigma that we are taking the money from the food centre and not using it towards the food centre. Its just a reassurance thing, that this is their money and if there is left over money at the end of the year, it goes back. It is a separate levy that we collect, but is also a service. Learn from it. Eric was talking to me about getting membership cards. But we have 13000 members.

U. Agebeyegbe - We're here to spend money, not take from the Food Centre budget.

F.Otello-DeLuca - UTMSU has a reserve, but its because we manage the whole building.

F. Noori - If the food centre needs more money they should just come to Fran about it and work it out. Maybe we should become more transparent so they know we aren't taking money from them.

#4. The UTM COMMISSION and COMMISSIONERS RESPONSIBILITIES

U. Agbeyegbe - The commissions meeting is a space for folks to come and express concerns and issues that they believe the students union should be addressing. It is also our responsibility within this space to listen to requests and understand others. Under the commission we do have certain ministries that fall under it, there is about 9 different ministries. The ministries are just a space aside from the commission to talk about certain issues, different issues specifically that folks want to talk about. We have the ministries listed below. Commissioners have specific responsibilities - to first of all, uphold the integrity of the Student's Union, and responsible to carry out the work we have discussed here, out to the general population and informing folks about what is happening within UTMSU. We are also here to ensure that whatever issues that have been brought to the table have actually been addressed. Commissioners should also find folks with similar interests and bring them back to the commission meetings, and we can talk about things more in depth, as well as include general members of the student population/body. We don't want to see the same people at every commissions meeting, or have the same discussions every time. The more people we have within this space, the better. My dream is at the end of the year when we have our commissions meeting in CC1080 or another large room on campus, and we can grow more as we move forward.

the services, advocacy and lobbying of the Union. The Commission of the Union shall designate Working Groups known as Ministries to focus on projects and campaigns.

Members of the Union shall become ratified members at a meeting of the Commission and/or Ministry and shall obtain voting rights immediately after ratification by the commission or ministry.

Commission and Ministry Procedures

- Commission membership expires April 30th of every year.
- The Commission shall have the right to implement their own procedures which must obtain Board approval.
- The Commission shall meet when and where it chooses at UTM, provided it meets at least once in September, October, November, January, February and March.
- Notice of meeting shall be given no less than seven days (7) before the start of the meeting.
- Every member has one vote and cannot proxy.
- Non-Director members may be removed from the Commission by a majority vote at the Board.
- Non-Director members cease to be members of the Commission when they fail to attend three (3) consecutive meetings in a row.
- Quorum is four (4) members of the Commission.
- The Commission has the right to strike working groups or ministries and to assist with the work of the Commission.
- All resolutions of the Commission have to be ratified by the Board.

Ministry of Education and Outreach

U. Agbeyegbe - The Ministry of Education and Outreach is a ministry that focuses on outreaching to students on campus, and also talking about issues with post-secondary education. So anything to do with tuition fees, fees in general, and food options on campus. If you are interested in any of these things, you can come talk to myself after, or VP External Naveed Ahmed who will be taking over this portion.

Ministry of the Environment

N. Alideeb - This is a space where we talk about sustainable activities that we can have on campus, and not just on campus but also in our community. To raise awareness about some of the things that are occurring on our planet. For example, we have Farmer's Market on our campus last year, this is promoting buying local, as well as eating healthy. Other events that we are planning throughout the year - Environment Week: where we will be planning a few activities including movies, basically just raising awareness about our environment and how we can improve.

Ministry of Equity

Z. Ramsha - The Ministry of Equity exists to ensure that students are treated equitably, regardless of race, gender, culture, or religion or sexual orientation. The ministry is an open forum for students to come in and express their issues and problems within the community and to participate. Raising awareness initiatives.

Ministry of International Student Issues

U. Agbeyegbe - We do have a Ministry of International Student Affairs as well, and there are about 20% of people on our campus who are international students on our campus right now. International students deal with specific issues that most of us don't even have to think about: tuition fees are four times higher, and can be upwards of \$40,000 dollars if they are staying on residence as well. We talk about issues and how we can combat ever increasing tuition fees for international students on campus. If you know any international students on campus, please encourage them to come out and take part of this.

Ministry of Part-Time Affairs

A. Moazzami - We meet every Tuesday starting next three weeks, essentially whats happening is we figure out what is happening with part-time affairs. As well as Mature Students affairs. We planned things like the Haunted Carnival, and USkills, etc. It is a lot of fun.

Ministry of Social Justice

Z. Ramsha - The Ministry of Social Justice is a forum where we discuss human trafficking, poverty, genocide, etc. and address all of these issues. This is not a forum only for discussion, but also for action, and taking action. One of the biggest events we hold on campus is Expression Against Oppression. All students are encouraged to come out and join.

Ministry of Student Life

R. Adade - Basically where students can get plugged-in about all of the social events that are happening with UTMSU. As well to get plugged-in using social media, and events that are being put up by our clubs and academic societies. This is a space where we can come together to come up with creative innovative ideas or share issues with particular events that could enhance student experience on campus, and just focus on their interests when it comes to activities and events that we have during the year.

Ministry of University Affairs & Academics

N. Alideeb - We talk about policies, offences, and student rights, for example the Drop Point Credit. Last year there was the student rights campaign where we were raising awareness of student rights. Moving on throughout the year, we want to have an academic integrity awareness week, where we talk about academic integrity and what it looks like within a university.

Ministry of Student Services

F. Otello-DeLuca - So, us as a union, one of the many things we offer is services to our students, and our services come in many different forms. The main one that folks may be familiar with is our UPass service, which is offered from the Union to give all of our students a very discounted price for transit for the whole year. Other services include: printing, info booth (tickets available), Blind Duck, student centre. This is a place for students to come together and discuss what services students need on campus, and making the whole university experience happen.

Questions & Comments

- U. Agebeyegbe Does anyone have any questions or comments?
- J. Visier I was thinking about the strike last year, and a student who was also registered with accessibility right? Because of the strike I had to drop a course, and because of a situation around OSAP, I didn't know where to go to, and I didn't know I could have gone to someone in the Student Union. Like where do I go, what do I do, who will represent me, etc. with accessibility, I'm part-time. What I was going to ask is looking at the different ministries, because I wouldn't think to go to Ministry of Education and Outreach, I wouldn't immediately go to it. How would you know which ministry to go to if it was a very intersectional issue, throughout different ministries?
- U. Agebeyegbe I guess it comes down to what the specific issue is. If it is Accessibility you would have to go to Ministry of Equity, if tuition fees you would have to go to Ministry of Education and Outreach, and if its part-time affairs you would go to the Ministry of Part-Time Affairs. Actually if you have an issue like this, you should just come here. This would be the best place to go because all of the ministries falls under this.
- S. Kazmi I was just curious as to do you ever have workshops for students for them to know their academic rights?

Jenny - There was actual workshops done, but we created a brochure so folks can read it in a way that isn't difficult to understand or comprehend. It was in bullet points, saying this is what you can do, this is what you can do, and if folks had questions they were more than welcome to come and ask Executives or Board members. But it is something to consider.

S. Kazmi - I think its one thing to write it down, a lot of students see paper and they just don't want to read it. But I think it could be really helpful for students to talk about it and their own unique issues. I graduated and I didn't get involved with the union until now, and I had so many issues with the registrar, and getting involved with the union and expressing my issues would have been much more helpful.

N. Alideeb - What we are pushing for this year is actually the Academic Rights of the students on the syllabus, because the first week of classes, the professor reads the syllabus and students already know this like the back of their hand, but we don't know our student rights. So actually having this on the syllabus forces everyone to read it. Also we have Vlogs that we put out online that will be talking about student integrity and rights, and we want to be making an academic integrity video specifically about student rights and where you can go get help and who you can talk to.

J. Visier - In terms of academic integrity this was one thing I was thinking about, in terms of accessibility. Say somebody plagiarism comes about when someone is having an episode, and they are not registered with accessibility for various reasons. There is so much stigma and shame attached to this and I'm not saying there shouldn't be consequences, but the process for even dealing with that (I don't know what it is), but it had people saying they had this moment, but they don't feel safe even addressing it. Now I'm not able to go to school. There is a level of ableism to it. This should be addressed.

H. Yussuf - Talk about Federal Elections, and how we can reach the students about that.

Accessibility Summary:

Psychiatrist on campus twice a week. Medical care on campus if we don't have access to OHIP. Fighting for healthcare on campus. Long psychiatrist waits (up to months for students). Birth control options, and testing confidentiality. How HCC gets their money is through student services, so it's student's money. Quality of Services to Students (QSS), they are bringing in another individual to campus, and more staff to bring in and talk to students. The HCC's argument to students however is if you want to see a counsellor it would still take longer than on campus, and how it's done here it is still fast. To those who are interested in this should wait it out. They have an on-call. What is considered an emergency? Possibly have a service connected with UTMSU, Accessibility and HCC. There is an Accessibility Coordinator on campus who works as a liaison. Plan of action: go to the HCC and see if there is any difference in wait times, also reach out to the HCC and inquire about their services and how their staff are being trained in regards to equity, and if they are trained at all. HCC levy group run through UTMSU. Students helping students. A lot of things just need to be advertised, as a solution. In order to introduce a levy, we would need to have a referendum. It could become very expensive due to staffing and certifications. Peer to Peer training, and equity and accessibility training to all staff. International student healthcare should be addressed and evaluated.

No means No / Consent Culture on Campus Summary:

Video. If a residence student got raped on campus, could they sue the school for that? What is the universities role? What about police? Updates on why consent culture is becoming so important. We don't have policies written out on campus. We need to have policies put in place, and educate as many people as possible. The emergency buttons at school do not work. Professors also need to become involved with this as well. Consent culture class that might be required (0.5 credit). A workshop instead? Victim blaming. Gender roles. Men speaking out about this. Have sessions on Consent Culture through other groups. First year transition groups. Make it more inclusive. If we have this class we should make it optional, so first years can have access to this information and not force them to take it. "Drunk means no, silence means no". Accessibility of the course - fees, and we want it to be as accessible as possible. Emphasis should be on consent in general. Intimate partner violence.

W. Khogali - I want to challenge everyone in this room to start thinking about different issues because talking them out here is the best plan of action. I also want to address Nour's point - the course does not have to come with a fee, it could be a free mandatory course that focuses on equity and consent culture. This isn't new, this happens in other universities as well. Do your research. This has a huge impact on

every student. Sitting from an employer stance - what does equity mean to you? Some students don't know what equity is. Change happens. We also have to understand privilege.

Orientation

Jean-Marc - Orientation is looking a lot more different than it has in past years. Now it is two days longer, we have the Monday and also the Friday was typically go downtown and collaborate with the other campuses.

Samia - Our vision this year was to make this frosh the biggest and most different/exciting frosh week ever. We have a bunch of new activities planned which are more expensive. So hopefully everyone can promote for frosh this year, through our website and social media. We're trying to make this as accessible to first years as possible.

Jean-Marc - Also we are trying to collaborate with academic societies and clubs. We thought of to have an academic portion of programming. We're trying to incorporate all aspects of university.

N. Alideeb - Also make sure to mention the bursaries are available.
