F. Nagata - This has been a busy month. We have also been doing a lot of planning for the future, setting dates on calendars for lots of events for the first semester. We started with our Board and Staff Retreat. We finalised our food centre and will have it up and running soon. Also I've worked on; Welcome Back Week, finalising things related to WUSC, and helping other executives with things they are

doing. Academic Advocacy week is on the go. We are putting a lot more of our focus into the upcoming orientation as it is coming soon.

- Y. Li Throughout July, I've been working on the Services Project. We are trying to extend the service of the Services programme by having bi-weekly services such as, massaging, meditation, barbers, etc. We are working on a proposal which will be finalised soon. Aside from that, I have been working on the HR for UTMSU staff, and working on the operating budget, and I have been working on events for the ACE students, for instance, a social night held on the past Friday.
- A. Posada Finalising the plans for Academic Advocacy Week which runs at the same time as Welcome Back Week. This involves collaborating with lots of academic societies to ensure they are promoting academic integrity. I've been working on the scripts for the Academic Integrity training module with the RGASC that first year students will be exposed to in order to be informed about the topic of academic integrity. Working on the mentorship programme in collaboration with academic societies. Next week will have destressors for the upcoming exam season.
- A. Abdullah Working with associates and the WUSC Coordinators to develop the WUSC programme and finalising everything. Primarily devising the logistics of WUSC events for throughout the year. The community and campaign for WUSC has been pretty much finalised. I've also been working on the food campaign for the year, and reviewing the food services on campus which are provided by Chartwells. We've taken a look at how Chartwells operates on other campuses, and what they are doing on ours. I've also been involved in redeveloping the UTMSU website. I've also had a few conversations with our App Developer, but I do not have any updates on that yet. Perhaps in the next couple of weeks. I've started planning for the International Students Orientation, IEC, and I've kickstarted the orientation for the Mature and Part-Time Students. I have also just recently returned from vacation last week.
- L. Arbaji We also have the Equity Centre that we're working on, alongside a multipurpose room in that space for faith groups. We will hopefully be adding things in there, finding resources, and making it a good space for our soon to be Racialised Students Collective and Queer Collective which will be stemming out from UTM. We have just finalised our schedule for 'Queer O' which will be happening at the end of September. We will also be finalising the Environment Week, which involves looking at how UTM can better manage waste, bringing in a panelist workshop. We also have XAO, which will have some events coming up from there, centred around 'Take Back the Night'. This last month, we've been working on Equity Training for Staff and Board members, and for Clubs and Societies leaders.
- Z. Tasabehji This past month, we had the world cup semi-finals and finals screening for two days. It was a great turnout which we were not expecting. We had over 80 people for both days, and ran out of food! I was working with Ramzi on Club recognition. We also did Club Executive 1 on 1s to see how the UTMSU can better help the Clubs. We held Club and Societies training, which went great. We also started planning Welcome Back Week, with our first Welcome Back Week meeting with Club and Societies Executives. We held two of our leader trainings for the upcoming Orientation, with another one coming up. We held our Toronto Island Trip with over 100 people turning up.

F. Nagata - The first thing that was changed was the logo. We also updated it to say August 2018. We updated the header. I also formatted the manual to make it less awkward. I fixed the page numbers. Because we are reviewing the policy monthly, the numbers are likely going to change because things are being added and taken out. This means this is not final, but it will be final for the purposes of this meeting. We also did not add to the table of contents three policies which were passed a long time ago. The policy that pertains to First Nations, Metis, and Inuit students is on Pg 82, Divestment and Ethical investments on Pg 84, and Access to Housing on Pg 85. Those are now added.

The first amendment was to the operational policies of the Board of Directors, and was made to the very last bit pertaining to proxies and voting. Andres and I took out the part that said "unless they are elected members of the Board of Directors". This is not possible, because the Assistant to the Board is a part-time job, and Directors can not have jobs within the union.

- V. Gomes How was the Assistant to the Board incorporated into meetings as a 'Board member' before?
- F. Nagata This is a correction of a paradox. The wording says that, "the assistant to the board shall not be entitled to vote, unless they are an elected member of the Board of Directors. This is not possible.
- M. Sajjad In the past, the Assistant to the Board is never actively involved with governance. The Assistant to the Board primarily works on the bureaucratic side of things.
- F. Nagata The role has a list of responsibilities. Moving on. The second bullet point for the Assistant to the Board now says "Commissions" instead of "UTM Commission". This will be reflected on the agenda. The Budget planning framework was mostly just correction in language, such as taking out the word "ministries", "UTM Commission". Finance Committee got replaced by the Budget Committee. Ministries no longer exist, and are replaced by commissions. The Executive Committee on page 10 has "UTM Commission" into "Commissions", as there are now 3. Valentino wanted to change the Executive Responsibilities change the wording to be 10,000 members to 14,000 members, to be more reflective of the current situation.
- M. Sajjad So what we are looking at for Executive Responsibilities in the Operational Policy, one of the things I was looking into was the amount of work the executives actually do, the overall stipend that they receive, and the overall flow of the organisation, as a review of the past few years. The workload that is often put on management, the amount of hours being put in, and how work is being distributed, it inspired me to go into a review. There was a bill that was legislated recently, Bill 148 in the province of Ontario, on the necessity to increase the minimum wage, the necessity to meet living wage standards to match inflation. Our wage has been under-paced for the last 6-10 years. There is also an overall understanding about how working conditions are for workers of any type.

F. Nagata - Just some final changes to mention. Part-Time has been changed from President to VP External, because it fits Atif's portfolio more. University Affairs took out the Environment, and put it under Equity. We added mental health initiatives, accessibility initiatives, and academic advocacy week. Part-Time initiatives and their representation falls under External, as previously mentioned. VP Campus Life no longer oversees the Poster Project, because it falls under the Member Services Portfolio.

- V. Gomes Back to the responsibilities for Execs. In terms of responding to adjustments for the commissions, I wanted to put up a motion for basically having the President oversee the commissions, even though they are not chairing them. Ie. VP External for Advocacy, VP Campus Life for Student Life, and VP Internal for Services
- F. Nagata Just to clarify, under the operational policy, the individual executive responsibilities of the President has been changed from Chairing to Overseeing. The VP External will chair UTM Campaigns and Advocacy Commission, VP Internal will chair the Services Commission, and VP Campus Life will chair the Student Life Commission. The term chairing is replacing supervising.
- V. Gomes Continuing with VP External, the following should be added: "acting as primary liaison for the Canadian Federation of Students (CFS)". It should remove "supervising the Ministry of Education, and outreach". Also, University Affairs should be changed to say it is chairing the Green Grants Committee.
- F. Nagata That responsibility moved to VP Equity.
- V. Gomes Oh. Also under VP Equity should be chairing of the Bursary Committee. Also, who are the liaisons for GCS and APUS?
- F. Nagata That would be Atif. As far as GSU, it works on a collaboration basis. Andres was the last one to contact them. Anything external would involve going through Atif.
- M. Sajjad During the session in camera, we held a discussion about issues that have been arisen. There was a discussion regarding some legal information that was passed on to myself that I brought back to this. There was an amendment brought forth to the Executive responsibilities and operational policy on page 11 which was not just the change from 10,000 to 14,000 members, but was a change to the minimum number of hours the Executive has worked. It is to change it from 30 hours to 40 hours. This is in recognition of the number of hours Executives actually work, as they work day-in and day-out on the regular. There were also a series of changes made to the individual executive responsibilities brought forward by Valentino. Furthermore, the remuneration which is on Pg 19, the discussion was had that the language for the overall annual salary for each of the executives, which was made in discussion with Valentino who is the director of this committee right now, will now read that the annual salary of the Executives be \$31,600, to account for working at \$15 per hour, 40 hours per week. This in accordance with the hours actually worked and in being paid a fair wage. Again, this change is to reflect the work of the students union, and to address legal opinions which were passed on to us. Valentino agrees, but I can imagine this will be up for further discussion at the upcoming Board of Directors meeting.
- F. Nagata On page 17, we the Orientation Coordinator responsibilities had added to it 'Welcome Week' in addition to Carnival Week. We crossed out the need for Orientation Leaders to report to the President, but kept that they report to VP Campus Life, but we added 'the other members of the Executive Committee'. We also took out 'on a daily basis'. The final wording is "The Orientation Coordinators must report to VP Campus Life and other members of the Executive Committee". We had an amendment to page 18 to Line Item E, where we added wording such as "UTMSU Equitable Practices", "are disrespectful to individuals, identities, and experiences". In full, it reads "The Members Services Coordinator or the Executive Committee shall review and approve all posters. The Union posters service is not required to accept jobs that express opinions of a political nature that are disrespectful to individuals, identities, and experiences". Then we have the changes that Munib and Valentino made,

such as changing wording from UTM Commissions to Committees and Commissions. The operational policy for sister unions on page 20 has had the old association taken out and replaced with APUS, which stands for Association of Part-time Undergraduate Students.

We are approaching the end of the summer and so far a lot has been done. I feel like I am finally settled into the role, but I wish I had been comfortable sooner. Some things has fallen behind in our plans as well, such as the app and the Food Centre.

CFS & Ontario General Meeting

We have just returned from the CFS Ontario General Meeting. It was a very nice space for student organizing, we went over motions for procedural changes in the organization and we had workshops to learn more about student activism.

I was elected the Queer and Trans Commissioner for the year, I hope to do work not only on my campus but also in the province around Queer and Trans Student issues such as the End the Blood Ban and gendered registration forms in OSAP.

The meeting overall was very productive, we learned a lot about Consent and how to dismantle rape culture, as well as many other equity related issues. We also reviewed the campaign for the Municipal Elections: vote local.

Student Centre Expansion

I have started the work on the Student Centre Expansion. We have created three action items that I hope to follow through before the month is over

First, we will create a tenant space to talk about improvements, monthly meeting will take place in the Student Centre. The need for such issue came up because many tenants do not have a written lease or contract with us, and as managers of the space it is our responsibility to provide such documents. We also want to ensure clubs and societies that are part of the space also have a say on what is happening with the building. Finally, we will use the meetings to engage tenants and other students on space management and the expansion.

Secondly, we plan on lobbying Clubs and Societies to start talking to their members. We will have all clubs and societies on the know about the expansion and how it would work. A creation of a commission space to address needs and issues: such as more prayer space or multipurpose rooms for art and performance clubs. Things like storage, lockers, services and others may also be discussed in this space. It will be an open committee to whoever want to participate

Lastly, we have started to move things around in the building. We are tightening the space to make room for more groups and services. ECSpert and CFRE plan on being moved as well as UCS to make space for the printing Centre. We will also launch our Equity Service Centre and we plan on bringing the food Centre into the building.

Policy Changes

I have decided to be proactive when it comes to the UTMSU's Policy Manual. I have scheduled a policy meeting every month, so we can fully review the Manual and fix all errors and mistakes that have not been fixed over the years. We also want to implement new policies, specially Issues Policies, for us to know how to address complications when they arrive.

In the policy meeting of August, we changed a lot of the language and fixed many details that were not fixed from two years ago. It was a very productive meeting and I hope the following will be just as productive.

A very busy week as a lot of planning for the rest of the year was done. As is the last month of the summer and school is kicking in soon I had to do a lot of work in policies and finalizing reports for the year. However, more importantly was making sure all major projects and policies were properly set up to have a productive year.

A lot of meetings with important campus partners was crucial, talking to different administration bodies to make sure our policies are being taken seriously and that

the interest of students is in mind. A lot of work with academic societies was great too, with the ASAC committee and the handbook. Once, September kicked off most of the focus went towards working on Orientation and later on Sauga Fest.

Academic Society Handbook
