1. CFS National General Meeting

The CFS National General Meeting took place between June 5th and June 8th in Gatineau, QC. General meetings are one of my favourite spaces because you get to connect with so many individuals from across the province and in this specific meeting, across the country. We talked about including menstral products in the Sexual Health Products Bulk Purchasing Program, the National Day of Action which will be taking place on November 2nd, 2016 (SUPER EXCITED FOR THIS!), and a national campaign against Islamophobia! At the NGM we also moved and passed an emergency motion asking for support from member locals to condemn the new UofT proposed policy called the Open, Accessible & Democratic Autonomous Student Organizations.

I am very excited for the Ontario General Meeting in August where we'll be discussing the details of the National Day of Action!



2. Policy on Open, Accessible & Democratic Autonomous Student Organization

The Policy on Open, Accessible & Democratic Autonomous Student Organizations is a policy being proposed by the University Administration that looks to create an appeals committee called the University Complaints and Resolution Council for Student Societies (CRCSS) which will be able to make decisions on behalf of our student organizations (clubs, academic societies, equity groups, and student unions). The UTMSU has taken a stance against this policy since it was first drafted a few years ago for two main reasons, 1) the process in which it was created was neither open, accessible, or democratic, and 2) the policy is not necessary.

1) When the policy was created it stemmed from the Student Society Summit that was hosted by the Administration to address some complaints made about the UTSU by some students. The UTMSU was invited to participate in the Summit in 2014 but withdrew because a number of our sister unions like the Scarborough Campus Students Union (SCSU), the Association of Part Time Undergraduate Students (APUS), and the Graduate Students Union (GSU) were excluded from the process. It made little sense to about concerns or a process that would dictate how student unions run when there were major stakeholders missing from the discussions. In addition, a

number of concerns were brought up about the Summit itself, like the fact that it lacked scope and purpose, and it was a very xenophobic and racist space. The space was not open, accessible, or democratic. At the time, the VP Equity, Melissa Theodore, complied the concerns, emailed them to the Administration and waited for a response. We got a response to these concerns two weeks ago, two years after Ms. Theodore originally sent them. Two years too late, and conveniently, two weeks before the policy is to be voted on at the Governing Council on June 23rd. The policy itself wants to create an external appeals committee composed of a faculty member that is chosen by the University Affairs Board (which is often has co-opted members, not done by elections), and 5 students from different student organizations and unions. These students are picked from a pool of 44 other students picked to represent each organization. We have seen this time and time again where UTM students are treated like second class students and where our representation is diluted to favour students at St. George. Though this policy may sound just, it actually further marginalizes UTM students. This is problematic.

2) The Policy itself is not necessary because the UTMSU and many other incorporated entities like APUS, GSU, SCSU and even the UTSU, have their own methods of dealing with complaints brought by students. For example, during elections if a student puts in a complaint about a process or something that has occurred pertaining to elections, the Elections and Referenda committee which is composed of executives and board members reviews the complaints and make a ruling on it. If the complainant does not agree with the ruling they can take it to the Appeals committee which is made up of 1 GSU rep, 1 APUS rep, and 1 SCSU rep. If the complainant is still not satisfied with the ruling they are able to take their issue to court (they can also access downtown legal services to make it more accessible). This has never happened at the UTMSU, but has happened at different universities like Carleton. The difference between Student Unions and other student organizations is that we are legally incorporated. Our constitution and bylaws are created by our students, for our students, and are strictly required to follow the Ontario Not-For-Profit Act. We have an obligation to uphold our constitution, but this policy would force us to break that, opening us up to litigation. We have an obligation to uphold our students' privacy, but by having the CRCSS we would be allowing non-members, who have no accountability to our students, make decisions that are binding. When this policy was brought forward to the UTM Campus Affairs Committee, a faculty member at UTM brought up the fact that there could be major conflict of interest with this CRCSS, by favouring rulings that are in line with the administrations political agenda. This in itself should raise red flags for our union. We have aspirations to do work on BDS, Fossil Fuel Divestment, Drop Fees, etc. If a student puts in a complaint about any of these stances the University can rule against this, withhold fees if they deem necessary and stop our work on this. Legally, and as per the Ombudsperson of UofT, policies and rulings such as these are not binding because we are a legal entity (I BCC'd you folks in that email). But the policy is being pushed forward anyway. I want everyone to think about the purpose of the students' union, and who we report to. We work for students, we are here to further STUDENTS interests, and this policy prohibits that.

I want to reiterate that this policy is not necessary.

3. Associate & Coordinator Hirings

We have officially hired most of our coordinators and associates. Unfortunately, because of the CFS NGM, some of our interviews had to be rescheduled to later dates. The postings were put up between May 16th, 2016 and May 29th, 2016. The review process took a week and we selected 105 candidates for the interview. The interviews took place on: Tuesday, May 31st, 2016 to Monday, June 20th, 2016. The hiring committee included the **Vice President Internal, the President, the VP Equity and the Executives** interviewing their respective coordinators. I have hired all of the coordinator positions under my portfolio and one associate. I will be reposting for my second associate.

We are currently reviewing applications for the Archives Assistant and will be posting the Internal Coordinator position up as soon as the hiring committee (which was struck last board meeting) meets.

4. UTMSU Orientation 2016

Since the last board meeting we have been working with the Office of Student Transition (OST) to create a schedule with minimal overlap. We have finalized that schedule and will be releasing it after our next meeting scheduled to take place on June 27th. We ran into some issues about whether or not we can make orientation free and though it is UTMSU's goal to make orientation as physically and financially accessible as possible, we realized that we are fiscally unable to make orientation week free this year. With that being said, there will be different packages for incoming students to chose from where some events will be free while events will require you to buy in.

This year we were able to get on the postcard that is being sent to ALL incoming first year students. The postcard will direct them to the landing page (uoft.me/UTMorientation) which will show them an array of orientation programing. From there students can select the UTMSU orientation button to find out more about our fun-filled week! Last year, due to conflicts with the OST we were unable to get on the postcard, and the landing page was unrepresentative of our orientation festivities. I'm very happy to say that this year we have been working together to minimize any and all tensions to further each of our interests and to provide for our students!

We had our first leader training on June 18th, which was a huge success! We officially announced this year's theme, SUPER '16 – MARVEL & DC which our leaders were immensely excited about. In essence, Marvel & DC are teaming up to combat the anxieties of starting university and challenging different oppressions through their super power (Amazing, right??)! During this training we had Union Workshops, where we split the leaders into groups to talk about each portfolio, what we do, and how they can get involved. We took photos for the Leader portion of the orientation website AND we had a karaoke social which was super fun – almost all of us suck at singing and its marvelous.

Executive Report #2 - May 23th - June 19th, 2016

Executive Summary

The last few weeks have been extremely tiring and draining. Most of the time has either been spent during meetings, check-ins, hiring, events, and sponsorship. I've already transitioned rather comfortably into keeping meeting minutes and agendas organized, and can now efficiently push along the reimbursements nicely as they come.

1. 69th Semi-Annual National General Meeting and CFS Skills Conference

On Friday June 27th, the entire exec team along with our OCs and several board members headed for York University to attend the Skills Conference. There, we met many individuals from different unions, communicated contact information, and learned in depth how to become a stronger advocate for social justice and accessibility to education. We also learned about the Fight the Fees campaign, Education is a Right, No More Stolen Sisters, and many more. We came back on Sunday and continued to work on other tasks the next week.

On June 4th, we went to Ottawa for the CFS NGM and worked on Policy, learned about a lot of people and issues, and did similar things as Skills, but on a national level. One of the main policies that local 109 pushed forward, was the one that was against the recent policy called "Open, Accessible, and Democratic Policy" for clubs and societies. This policy not only makes the process less democratic, but also challenges the autonomy of a legal entity that is the UTMSU and other unions. In addition, we also passed many other policies that suggested progressive change amongst the student body.

2. Part Time Staff Interviews

The deadline for job applications has finally passed, and the exec team went through their respective portfolio applications and cover letters to determine the best choices to interview. On average, 2-5 applicants were given interviews based on qualification and how many vacant positions there were. By now, most of the positions have already been filled, and some were left vacant for repost, or still under review. The process involved myself (VP Internal and Services), President, VP Equity, Executive Director, and whichever corresponding supervisor for the job (such as VP External for WUSC coordinator). The process was professional, completely followed, and interviewers that were close friends of the applicants stepped out because of conflict of interest. As of now, most positions have been filled and we're just waiting on them to sign confidentiality contracts, so they can start working.

3. Grad Formal

The planning of grad formal was relatively recent for a large scale event, mostly because the entire team was so preoccupied with retreats and other tasks, but we managed to hold a few budget meetings and pull of the event successfully. We also picked up the prizes and teddy bears, which led to us having another potential supplier with decent rates.

4. Policy on Open, Accessible and Democratic Autonomous Student Organization

This policy that the administration recently passed at the UAB is rather undemocratic, greatly imbalances the power dynamic between student unions and admin, and is a direct challenge to our autonomy. Because of this, we have already passed the bill and asked for support during CFS, along with GSU, APUS, SCSU, and other member locals to stand in solidarity on fighting this bill. We've also met with the vice provost, Sandy Welsh, and other members of senior administration to lobby them to reject the bill.

5. Frosh

After multiple discussions, I finally went to the first meeting with Student Life (OST) and discussed with everyone else the financial ramifications of making orientation (free) and how admin would have to give us \$60,000 to even make it remotely possible. Unfortunately, we couldn't get the funding, but we finally agreed with admin that we could have a 2 tier system by making some aspects of the orientation free, but also have a specific set that includes big ticket events and charge minimal fees. Regarding T-shirts, we've decided to go with CFS shirts that are fully ethical only for the leaders, but Alstyle promotions also have proper documentation regarding ethical production, so we got it for all the froshies since it would be a lower cost.

6. Sponsorship and Handbook

The deadline of the handbook was supposed to be today, meaning that all the ads would have been sold earlier and followed through upon. There was a much larger increase in revenue this year, which would be slightly beneficial to cover some of the costs related to printing the handbook. This last month was also an important time to negotiate with some of the old sponsors, and hopefully retain them, since last year most of them left orientation week extremely dissatisfied. Fortunately, the sponsorship coordinator has been hired, and there is already a plan to contact most of the old partners, along with many new potential partners that would make frosh safe and most cost-efficient.

1. 69th Semi-Annual National General Meeting

We attended the 69th CFS Semi Annual National General Meeting in Gatineau, Ontario from the 4th of June to the 8th of June where we had the opportunity to meet with other delegates and other student unions from across Canada. I had the opportunity to also sit in the Racialized Students Constituency group, the Women's Constituency group and the Policy Committee as a Women's representative. I had the opportunity to help amend a motion that was brought forward during the opening plenaries of the national general meeting. We were also able to bring forward an emergency motion to the national general meeting on the new policy on open, democratic student autonomy where we had a lot of student representatives from across Canada show support and solidarity for our motion and were generally against the university's push for the establishment of this policy.

2. Part Time Staff Interviews

We started the interview process for a majority of our part time staff hiring and we are almost done with those interviews. Some portfolios like mine, which aren't very big or encompass a lot of staff were all done with interviews in one day. I have currently already interviewed and offered offers of employment, through Jackie (VP Internal), for my associates and the International students coordinator.

3. Frosh Leader Interviews

Last week Thursday, we started having interviews for the frosh leaders of 2016-2017. These interviews were done on Thursday, Friday and Saturday. We complied the list of all the frosh leaders we wanted with the OCs, the Orientation Logistic Committee as well as with the exec and had emails sent out to them by Monday in order to give them enough time to prepare for the first leaders training that is happening this Saturday.

4. Policy on Open, Accessible and Democratic Autonomous Student Organization

On May the UTMSU received knowledge on a policy that the university was trying to pass at the University Affairs Board which would directly hinder and affect our organizations effectiveness, decision making, constitution and bylaws mandated by the students. This policy is undemocratic because it sets up the administration as a parent to our organization and gives them the power and the right to overturn and 'recommend' actions and policies that we should do and follow and if we do not follow this policy, they would have the power to withhold our dues from our membership. This is extremely problematic in the long run because if we don't get our dues it directly affects the clubs and societies who get funding from us, we won't be able to run as an organization and provide services and events for students and it will give administration power essentially over us. This policy was passed at the University Affairs Board and was pushed forward to the Governing Council, who will have a meeting on June 23rd where this policy may or may not pass.

What UTMSU has done since we found out about this policy is the following:

- We have contacted our clubs and societies on campus and informed them on the policy and how it affects them. We also had an information session with them on June 16th so discuss initiatives to engage the student body moving forward to the meeting.
- We presented an emergency motion at the CFS National General Meeting and made this aware to all the student union representatives in Canada as well as the Executive of CFS.
- We have met up, had meetings with and recorded an information video with our sister student unions of APUS, GSU, SCSU.
- We have been meeting up and lobbying different governors of the governing council about how the policy is indeed undemocratic and problematic.
- We have released and been doing a social media campaign under #Students4Students where we circulated information on the policy and how its problematic as well as the video that we recorded.
- We have also been trying to engage the student body steadily through our outreach initiatives.

5. Frosh

We are still currently on the planning processes of Frosh. We have a good idea of how our partnership with Student Life will be like in terms of scheduling. We ae currently just trying to figure out how much it will cost both sides as well as how much we will be charging students. We already have the theme and the dynasties figured out as well as the events that will be occurring during frosh.

However, she mentioned that she recognizes the importance of organization and deadlines and pointed out that societies submit their documents on time. Nour Alideeb explained that the only reason they have ever been late was due to personal reasons. She also mentioned that sometimes clubs are late because they cannot find the appropriate documents due to disorganization.

Jacke (Pu Qi) Zhao discussed that funding should not be cut unless absolutely necessary and with improving the UTMSU website, communication and outreaching this should be less of a problem (not to say this is not a problem but there are other ways to improve it).

Nour Alideep discussed the importance of improving ourselves first before starting to give penalties. She mentioned that when submissions are late, it impacts clubs themselves because they get their funding late.

Jackie (Pu Qi) Zhao mentioned that many club representatives come into meetings late or not show up at all and are disrespectful to deadlines/guidelines. For this reason, he stated the importance to take this into consideration seriously.
