F. Dayla: This past month has been super busy with orientation. This past month, I've been specifically working on figuring out how Upass is going to be delivered to the students in fall. We have been dealing with the T Card office and working closely with the Upass coordinator, which includes hiring Upass clerks, figuring out how we are going to distribute Upass in person, given that we're in the middle of a pandemic. And that includes ensuring that we're following proper safety procedures and protocols, including sanitisation, social distancing. Apart from that, we hired a full time staff

position for the campaigns and academic advocacy coordinator position this past month. I've been working on services

along with my associate and researching how we can have new research, how we can have new services. We have a couple of ideas we have and we have started looking into the possibility of those. So that is something we've started working on. I also have been working closely with the sponsorship coordinators for sponsorship for Frosh and that has been pulling up pretty smoothly. I've also started working on the operating operating budget this past month. It will be finalized by the end of August and early September. So the next board meeting will have that ready to be presented as well.

A. Sokhi: The past month has been quite heavy in society recognition that I'm just trying to make sure that they have all their documents and they have all the support that they need in case of any missing documents. I've been in touch with them and I've made sure that their recognition packages are complete. Other than that, I've also been working on making sure that any society past funding has been allocated to them or they know that they have checks to pick up. Other than that, we've also been working heavily on the education for our campaign, which has taken up quite a lot of time in the month of August. We've made sure to mobilize our students to make sure that the message gets across with the email. If folks have not sent an email yet. Please be sure to. That's been something that we've been working on. Other than that, like Fahad said, this month has been extremely heavy in kind of orientation. So just making sure that I'm there to support the organization committee.

L. Pan: As for the external panel, we've been also working on the research for all of our campaigns. And other than that, we've been working on our own budget department to support it, including the Wechat Team, which have also been having discussions on our budget and our and our planning, our Chinese orientation, which is happening at the beginning of September. And in addition, we think all the executives have been shooting videos, including our introduction video as we just put up the video for orientation.

M. Yakubi: It's been busy as that orientation is approaching, as you folks would expect. There's a lot of things that we need to work on as a team. So we've been orientation heavy this month. But we've also done a lot of other things, such as meeting with folks that are external to the UTMSU to discuss, like TTC and transit in general so that we can actually bring the needs of our students to the table. This conversation also is needed just because UTM is a commuter campus and there's a lot of meetings when it comes to transportation and our students. Another thing that we've been working on has been a lot about the Upass itself. As you folks may imagine what they call it, things are a lot more difficult. So myself, Farhod, as well as some full time staff and Upass coordinator has been working really, really heavily on figuring out a system that actually works best. It involves meeting with the figures, with administrative figures, as well as our internal team in order to determine what a safe protocol looks and how we can ensure that, folks, we're checking eligibility before. Signing up for Upass. So folks do have some questions, you can just visit our social media accounts because that's been posted yesterday, just outline step by step what you need to do to pick up your Upass essentially begins with the form and then you will be directed to a new page so you can actually book an appointment. So that's been very, very heavy. We've also had the opportunity to shoot our executive video. That's something that we've been working very, very heavily on as well. We will have a part for you starting tomorrow as well just to get that done.

The next thing that I've been working on is working really closely with my team just because there are quite a few of them and supporting them through the work that they do. We've been doing a lot of research for the Education for All campaign, preparing to lobby the administration and in September, essentially before school starts, because we need and we deserve accessible and inclusive education and we're going to make sure that when the faceprint fights for our students. I have been working very, very closely with my volunteer coordinators in organizing volunteers, in organizing volunteers for organizing volunteers for the or the year as well, just seeing how volunteers can be better branded. With my associate we've been

And there has always been a lot of work with our promotion coordinator as well, and has been heavily involved in the work that we do for Frosh, including taking videos, editing content, and also having brainstorming sessions with the executives so we can have a communications plan going forward. So I guess that's a little bit of what the executives have been doing. And I can also give a little bit of updates on Noha and Tarwah. And I know, Noha has been working very, very closely with folks to arrange some seminars. And they've been very busy with determining what the food center operations are going to look like as a team. So folks are looking for alternative ways to still give our services to our students during a pandemic. As for Tarwah, it's been orientation heavy, as you may imagine. She's the VP campus life. She's also been working very closely with my team and her associates in order to get the re recognition packages of the clubs done. As Anushka mentioned, there was an email that was sent out to both our clubs and as well as our societies that outline, hey, congratulations, you've been approved or, hey, you haven't been approved. And here's some of the next steps that you folks will have to take. So that's one of the things that the executives have actually done.
