In the reading week, we hosted our first ever Cooking Class. I got to deliver fresh groceries for that. It was in collaboration with the Food Centre, so thanks Noha & Mitra for helping us. We had our Black Professionals Panel, and tonight we will have our Closing Ceremony. It will be fun, we will have KAraoke, and other activities. Besides BHM, I worked with Felipe, figuring out elections for our campus groups, and how they look in the online world. (inaudible). We hired CROs for the elections, and are training them on how elections will be conducted this year. (inaudible). The End of Year social will happen soon as well, so stay tuned for more information.

N. Farawi: (inaudible) The Food Centre was closed due to the lockdown, we are getting fewer students but that makes sense due to students not being on campus. (inaudible). We will also be

renovating the Food Centre very soon. We will start distributing seeds, and gardening kits via the Food Centre. The Equity Census is also happening, we worked with SCSU on that. (inaudible). Tarwah also mentioned Multicultural Fest x XAO. We will also assess the bursaries soon, the deadline was last week. The Equity Handbook was released this week, so do check it out.

A. Sokhi: I have been working on planning Academic Advocacy events with Jihan, so working with the respective offices on campus. Students have a lot of accommodations, religious and time zones, so we will be talking about this with the registrar. It is also a safe space to talk about financial accommodations as well. I also worked on UTMSU Departmental Meetings, along with other folks, we have been meeting departments across UTM talking about our initiatives and demands, and what their feedback and support looks like. I have been assisting students with academic offenses. Along with Tarwah, I have also been working on Campus Groups awards. I have also been meeting with ASAC.

L. Pan: Happy (inaudible) to everyone celebrating. This is the last week for CNY celebrations. We are wrapping things up. We got a chance to meet with MP Iqra Khalid and we discussed the pandemic's effects on students. I also attended COSS Meetings during the reading week. We voted on proposals regarding Student Life, and Hart House. We voted against the fee increase in Hart House, and in favour of fee reduction of Student Life. However, the motions still got passed unfortunately. My team is also planning for Women's Day, which is coming on March 8. It will be open to students and faculty, and recognizes themselves as women.

F. Dayala: Hey everyone, February was a good and fun month. We worked on hirings, for CRO & DRO for Spring Elections. The EARC finalized those hirings. We hired CROs for Academic Society elections. We are also hiring Poll Clerks for Spring elections, do recommend to students if they are interested. We had financial literacy workshops on 10 and 12 February, which went great, we collaborated with CRA, and had over 110 people attend. We are having our Tax Clinic starting in March which will provide free tax filing services to students. Tax volunteers will be helping them. The volunteers were trained over the reading week. We released student business promotion graphics, which is an exciting initiative from UTMSU to support and promote student run businesses, and promote them specially in the pandemic. Please do refer it to students, I'm super excited for that. We are also planning to collaborate with the Career Centre for 2 workshops, regarding Resumes, and Hirings for the summer session. I'd highly recommend y'all to attend. Registration is required. Spring Elections are starting soon, so work on that has been done as well.

M. Yakubi: (inaudible). I highly recommend you to look at their lobby document, it's small and short, it mentions things on what they can use the finances for, and what a new vision for Post Secondary education in Canada looks like. We also mentioned how we are hoping to see more support from the Government, and they will take back these things to the House of Commons. If you're interested, please go to the CFS Instagram, and check out their Instagram page so you can know how we are lobbying. Other than that, we met with MP Iqra Khalid and Minister Menitino regarding UTM specific issues. We are hoping to continue these conversations regarding housing, employment, vaccinations, and being equitable overall. We are continuing to operate the Peer Support Program, please share them, and we will be sharing a video series for promotion. The Laptop Rental Program is continuing as per normal as well. I also sit on the Equity Census Roundtable, and a lot of great conversations, and feedback has been shared there. I attended the Ontario Executive Committee Meeting this past month. We had the VolunTEAM social, and hirings, which Fahad already talked about

Be it resolved that the UTMSU Board of Directors approve a cost of living increase\* to the UTMSU WUSC Levy Fee designated for Academic Societies from \$0.76 per session, per member, to the newly adjusted rate of \$0.77.

- \*CPI increase based on the Ontario December 2019 to December 2020 consumer price index determined by Statistics Canada.
- M. Yakubi: Essentially, this is an increase due to CPI, and we went through what the CPI is last time.
- F. Dayala: I wanted to mention that we had approved this previously, but we are re-approving this because there was an error in the previous amount by UofT, and we were informed of that. Thus the correction is being made here.

Be it further resolved that the UTMSU expend up to \$20,000 for the purchase of new equipment (and its installation) in the Presentation Room from Budget Line Item: 3.20 - Student Centre Management

F. Dayala: As folks know, the Student Centre is older than me and when the building is so old, we do need renovations and upgrades from time to time. We wanted to get these funds approved so we can do these upgrades before students resume back to in-person. We are planning to set up a new room for our Campus Groups, so they can have a meeting space. The second set of funds is to improve and upgrade the Presentation Room, its old, the technology there is outdated, and it'll be good to upgrade it now, so we can be ready for next year.

M. Yakubi: The Campus Groups Room is an on-going goal for the UTMSU, since this was a problem for the Campus Groups in previous years. It'll be a good resource for our clubs & societies.

S. Naderi: How long will it take to finish?

N. Alideeb: The Campus Groups space already exists, we're just getting new furniture, due to the pandemic, orders are delayed, but hopefully before the summer this can be done. We reached out to 3 vendors for the Presentation Room, and then decided. Hopefully by the Summer time this will be done as well.

M. Yakubi: As Fahad said, this is the perfect time to do these renovations, since students are not on campus right now. Once these upgrades are done, we can share pictures and inform you all, and our members.
