a) STUDENT SOCIETY MEMBERSHIP FEE (UTMSU FEE)

Be it resolved that the UTMSU Board of Directors approve a cost of living increase* to the UTMSU full-time student society fee from \$37.51 to the newly adjusted rate, \$39.76 per session, per full-time member.

Be it resolved that the UTMSU Board of Directors approve a cost of living increase* to the UTMSU part-time student society fee from \$1.22 to the newly adjusted rate, \$1.29 per session, per part-time member.

*CPI increase based on the Ontario December 2021 to December 2022 consumer price index determined by Statistics Canada.

b) ACADEMIC SOCIETY FEE

Be it resolved that the UTMSU Board of Directors approve a cost of living increase* to the UTMSU student society fee designated for Academic Societies from \$1.19 per session, per member, to the newly adjusted rate of \$1.26.

*CPI increase based on the Ontario December 2021 to December 2022 consumer price index determined by Statistics Canada.

Be it resolved that the UTMSU Board of Directors approve a cost of living increase* to the UTMSU student society fee designated for the Food Bank from \$0.64 per session, per member, to the newly adjusted rate of \$0.68.

d) STUDENT REFUGEE PROGRAM FEE (WUSC FEE)

Be it resolved that the UTMSU Board of Directors approve a cost of living increase* to the UTMSU fall/winter full-time student society fee designated for the Student Refugee Program from \$2.08 to the newly adjusted rate, \$2.20 per session, per full-time member.

Be it further resolved that the UTMSU Board of Directors approve a cost of living increase* to the UTMSU summer full-time student society fee designated for the Student Refugee Program from \$0.81 to \$0.86.

Be it further resolved that the UTMSU Board of Directors approve a cost of living increase* to the UTMSU fall/winter part-time student society fee designated for the Student Refugee Program from \$1.28 to the newly adjusted rate, \$1.36 per session, per part-time member.

Be it resolved that the UTMSU Board of Directors approve an increase to the UTMSU Fall/Winter 2023-2024 student society fee designated for the Mississauga U-Pass Transit Fee from \$144.74 to the newly adjusted rate, \$157.77 per member, per term.

Be it further resolved that the UTMSU Board of Directors approve an increase to the UTMSU summer 2023 MAM student society fee designated for the Mississauga U-Pass Transit Fee from \$93.87 to the newly adjusted rate, to \$97.75 per MAM student.

Be it resolved that the UTMSU Board of Directors approve an increase to the UTMSU student society fee designated for the Accidental Health Plan from \$\frac{102.09}{102.09}\$ to up to \$\frac{112.30**}{102.09}\$ per member, per term.

Be it further resolved that the UTMSU Board of Directors approve an increase to the UTMSU student society fee designated for the Dental Plan from \$85.34 to up to \$93.87** per member, per term.

**The final increase may be lower than 10% once the Health and Dental Plan experience report is made available by Greenshield Canada.

#6. PRESENTATION OF OPERATING BUDGETS

a) APPROVAL OF BLIND DUCK PUB OPERATING BUDGET

Be it resolved that the Operating Budget of the Blind Duck Pub be approved as presented

- This budget is for regular maintenance for the Blind Duck Pub
- Adjustments (highlighted in yellow on Appendix A) are made based on the trend from this year
- Ex. Sales Revenue
 - Food line increased because there are more students going to the Blind Duck
 Pub this year
- Alcohol Labour Income is a licence income paid by the university since the Pub is the only place on campus where alcohol is served

b) APPROVAL OF UTMSU OPERATING BUDGET

Be it resolved that the Operating Budget of the UTMSU be approved as presented

 - Adjustments are bolded
- Schedule 3
 - There were no U-Pass refunds before the beginning of this year, so it was not accounted for in the preliminary budget
- Schedule 4
 - Orientation cost was higher than expected because there was a lower sponsorship amount than expected
- Schedule 5
 - The cost for the by-elections was lower than expected, so it is expected that the cost for the spring elections would also be lower than previously expected
- Schedule 6
 - Salaries and Benefits was increased because salary increase was approved in the October Board meeting
- Schedule 7
 - Wechat Team expenses was increased, but there is a higher sponsorship amount than expected, so the total expense for Schedule 7 did not change
- Schedule 8
 - Levy fee increases approved today affects next year, not this year, so it is not reflected in this operating budget
